### **Requirements & Eligibility**

- Decal Sizes & Placement

Truck: (2) 8" Hex decals placed on the side and (2) 4" Hex decals forward facing (headlight/valance)

Buggy: (2) 8" Hex decals on the side and (1) 8" Hex decal centered on the skid plate

**UTV**: (2) 4" Hex decals on the side and (2) 2" Hex decals forward facing **M/C**: (2) 2" Hex decals forward facing and (1) 2" Hex decal on helmet

Must exclusively use Baja Designs product

Must be registered with Tech Inspection/Contingency

- Minimum 5 entries in class

Baja Designs product must be displayed on vehicle at all times and use a minimum (1) Light Bar or (2) Auxiliary Lights on day races when lighting is not needed. Any claims submitted without photo verification and/or does not have forward-facing daytime light will not be honored.

The undersigned, does hereby, for himself, his heirs, next of kin, executors, and assigns, in consideration of and as a condition of the furnishing and/or servicing of Baja Designs lights or other products, release and forever discharge BAJA DESIGNS, INC. their subsidiaries and affiliates, their individual officers, directors, agents and employees, successors and assigns, herein collectively called "the Releases", of and from any and every claim, demand, action, cause of action or rights of action of whatsoever kind or nature, and any cost, loss or expense, including attorneys fees, which the undersigned had, now has or hereafter can, shall or may have against Baja Designs in connection with arising out of, or relating to any use made by the undersigned of Baja Designs lights or products and/or Releases or their agents servicing of such products.

The undersigned specifically acknowledges that he is or will be engaged in racing or racing-like activities which are inherently dangerous, and the undersigned acknowledges that he is assuming the risk of injury, death or property damages arising out of or resulting from the use of Baja Designs brand lights and other products in connection with such dangerous activities. The undersigned also acknowledges that this waiver and release covers any claim, demand, action, cause of action or right of action for any injury, including quadriplegia, loss of limb or its use, death or property damage resulting from or arising out of any accident or occurrence during or in connection with the use of Baja Designs brand lights and/or Baja Designs products and/or the servicing of same by Baja Designs or its agents, including specifically claims or damages arising out of manufacturing or design defects or out of negligence, fault or other culpable conduct of Baja Designs or its agents.

This waiver and release shall be construed in accordance with, and shall be governed by, the laws of the State of California.

The undersigned specifically waives right to a jury trial and agrees that any claim or controversy arising under this waiver and release shall be submitted to binding arbitration in San Diego, California pursuant to the commercial arbitration rules of the American Arbitration Association then in effect. The decision of the arbitrator shall be final and binding and may be entered in any court having jurisdiction over the parties. In the event of the bringing of any action or arbitration by either party hereto against the other arising out of this waiver and release, or the subject matter hereof, the party who is determined to be the prevailing party shall be entitled to recover from the other party all costs and expenses of suit, including reasonable attorneys fees.
